- Pay an amount towards secretarial assistance either lump-sum or on per student basis, which is more, as per approved rates.
- Will provide five sets of Self Instructional Materials and one set of audio video cassettes pertaining to the programme
- Pay to the host institution for use of laboratories and equipment at rates approved by IGNOU from time to time.
- Appoint counselors as per IGNOU norms out of proposals made by Programme in-charge.
